The National Archives and Records Administration (NARA) is the repository of the permanently valuable records of the U.S. Federal Government, with facilities open to the public for research in Washington, DC, and College Park, MD; and at 12 regional archives; 2 personnel record centers; and 15 Presidential Libraries. Bring photo identification (such as a driver's license) and learn about the researcher registration process and research room rules at www.archives.gov/research/research-room-rules.

The National Archives Building, 700 Pennsylvania Avenue, NW, Washington, DC 20408, www.archives.gov/dc, contains many records about noncombatant civilians connected with the Union Army during the American Civil War. However, the records are underutilized because there is no comprehensive index, no "one" place to look, and requires time-consuming research into obscure records. Digitization is <code>slowly</code> improving that situation, however! This lecture will provide suggestions for research with emphasis on online <code>or</code> alphabetical materials that can help you get started.

The National Archives Catalog, <u>catalog.archives.gov</u>, has digital images and information about NARA's holdings.

- In this handout, NAID means "National Archives Identifier," which is a unique number given to every record group, record series, file, item, bibliographic term, image, or digital object in the Catalog. You can search for the NAID as well as for names and other words.
- Play with the Catalog. Search in different ways, and become comfortable with how it works.
- Search for surnames and/or geographic place names of interest annually!
- Only about 1 percent of our holdings are digitized according to our Record Group Explorer Data at www.archives.gov/findingaid/stat/discover.

TEAMSTERS AND WAGONMASTERS:

Teamsters drove wagons with the Army's supplies. Wagonmasters had charge of the wagon train. It is necessary to know the name of the officer, regiment, or unit under which he served, and then dig into obscure records.

The most common occupations are clerks, superintendents of stables and ambulance trains, wagonmasters (and their assistants) and forage masters, but there are also agents, ambulance masters; carpenters; carters; cleansers of leather and collars, draughtsmen; drivers; inspectors and their assistants; laborers; messengers; receivers; and day and night watchmen.

NURSES, COOKS, LAUNDRESSES, AND MATRONS:

Records about women who served in these roles often overlap, and the same woman may have served in all four capacities at different times, so it pays to explore all records regardless of occupational label. Many men also served as nurses. For an overview of the research process and records about laundresses, see "Union Army

Record Group 15, Department of Veterans Affairs - Approved and disapproved pension files.

- Step 1: Look for the nurse's name and pension file number(s) in T288, *General Index to Pension Files*, 1861–1934, available online on Ancestry.com and FamilySearch.org at (www.familysearch.org/search/collection/1919699), **or** in T289, *Organization Index to Pension Files of Veterans Who served Between 1861 and 1900*, which is available online at Fold3.com and FamilySearch.org (www.familysearch.org/search/collection/1471019).
- Step 2: Go to the National Archives Building (www.archives.gov/dc) to see and copy the pension file yourself, or order a copy of the COMPLETE file online at eservices.archives.gov/orderonline.
- Note: Pension files for two nurses are online: Emma M. Fogg French (NAID 142666395) and Mary E. Chamberlain Perkins (NAID 124081524).

Record Group 105, Records of the Bureau of Refugees, Freedmen, and Abandoned Lands

Many records for Southern states have been microfilmed and digital images can be found online. Record Group 217, Records of Accounting Officers of the Treasury

The Catalog gives the names of all 180 claimants, and the date, place, and nature of the claim. Files usually contain affidavits, correspondence, and other supporting documents naming soldiers (often deceased or deserted) who failed to pay. Most claims were rejected because of a lack of evidence of the soldier's indebtedness on the military muster rolls or payrolls.
- (2) Registers of Private Medical Claims, 1863–1884" (NAID 2600716), catalog.archives.gov/id/2600716. 4 volumes. Arranged by time period, and then alphabetically by first letter of claimant's surname. Entries show the amount claimed, an explanation of the claim, dates received and confirmed, and a certificate or settlement number. These claims were usually for the services of doctors or nurses, laundry, and medical supplies.

SUTLERS:

Sutlers were traveling storekeepers authorized by the Union military to follow the troops and sell them goods and foods that were not part of the Army's daily ration.

<u>Publications</u>. Researchers should start with publications before delving into archival records. Many can be found online at Hathitrust.org (<u>www.hathitrust.org/</u>), Google Books (<u>books.google.com/</u>), and FamilySearch.org (<u>www.familysearch.org/en/</u>).
