## Certificate of Vote

We, the undersigned, ELECTORS OF PRESIDENT AND VICE PRESIDENT OF THE UNITED STATES OF AMERICA, being duly and legally appointed and qualified by and for the Commonwealth of Massachusetts as appears by the annexed certificate made and delivered to us by the Executive of the Commonwealth, having met and convened agreeably to the provisions of law at the State House in Boston in the Commonwealth of Massachusetts, on the first Monday after the second Wednesday in December next following our appointment, being the fourteenth day of December in the year two thousand and twenty,

DO HEREBY CERTIFY that, being so assembled and duly organized, we proceeded to vote by ballot, and balloted first for such President, and then for such Vice President by distinct ballots,

AND WE FURTHER CERTIFY that the following are two distinct lists, one of the votes for President, and the other of the votes for Vice President, so cast, for the respective terms beginning at noon on the twentieth day of January in the year two thousand and twenty one.
