Dear Mr. Delery:

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to the incumbent President of our intent to open George W. Bush Presidential records in response to the systematic processing projects and Freedom of Information Act (FOIA) requests listed in Attachment A.

These records, consisting of 29,171 pages, 3,786 assets and 9 video clips, have been reviewed for all applicable FOIA exemptions, resulting in 1,483 pages and 163 assets restricted in whole and 460 pages, 19 assets, and 1 video clip restricted in part. NARA is proposing to open the remaining 27,228 pages, 3,604 assets and 8 video clips in whole and 460 pages, 19 assets, and 1 video clip in part. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing former President George W. Bush's representative, Freddy Ford, of our intent to release these records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is October 4, 2023, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.

Bush Presidential textual records proposed for opening are memoranda and presentations; meeting agendas and summaries of meeting discussions; drafts of homeland security legislation; talking points; daily briefing memoranda; correspondence sent to the White House, particularly to Chief of Staff Andrew (Andy) Card; news clips and case law; printed prototypes of a new student visa application website; and White House responses to Q&As from media organizations. These records regard visa proposals after the September 11, 2001 terror attacks: how to register applicants for different types of visas to satisfy the need for greater border security, while responding to concerns the new rules made legitimate travel more difficult and charges from foreign nations and their nationals within the United States that the revised rules were discriminatory. These materials are from the White House Office of Records Management Subject Files, the Homeland Security Council and the White House Office of Homeland Security. The George W. Bush Presidential electronic records proposed for opening include email correspondence and discussion about some individuals denied visas after the September 11, 2001 terrorist attacks. Additional email includes research requests for case law and findings as well as Department of Homeland Security News Briefings. These materials are from the Automated Records Management System (ARMS), Exchange Email, and WHO Share Drive Search and Access Sets.

In accordance with the requirements of the Presidential Records Act (PRA), as amended, 44 U.S.C. §§2201-2209, this letter constitutes a formal notice from the National Archives and Records Administration (NARA) to you, as former President George W. Bush's representative, of our intent to open George W. Bush Presidential records. These records were processed under the systematic processing project and Freedom of Information Act (FOIA) requests described in Attachment A.

These records, consisting of 29,171 pages, 3,786 assets and 9 video clips, have been reviewed for all applicable FOIA exemptions, resulting in 1,483 pages and 163 assets withheld in whole and 460 pages, 19 assets, and 1 video clip withheld in part. NARA is proposing to open the remaining 27,228 pages, 3,604 assets and 8 video clips and 460 pages, 19 assets, and 1 video clip in part. A copy of any records proposed for release under this notice will be provided to you upon your request.

We are also concurrently informing the incumbent President of our intent to release these George W. Bush Presidential records. Pursuant to 44 U.S.C. 2208(a), NARA will release the records 60 working days from the date of this letter, which is October 4, 2023, unless the former or incumbent President requests a one-time extension of an additional 30 working days or asserts a constitutionally based privilege, in accordance with 44 U.S.C. 2208(b)-(d). Please let us know if you are able to complete your review before the expiration of the 60 working day period. Pursuant to 44 U.S.C. 2208(a)(1)(B), we will make this notice available to the public on the NARA website.
