Selected Records Relating to Human Rights in Brazil, 1964-1985, at the National Archives and Records Administration

The following is an overview of selected records at the National Archives and Records Administration concerning human rights issues in Brazil between 1964 and 1985. I. General Records of the Department of State (Record Group 59)

A. Central Files

The primary source of Department of State records for documentation on events in various countries is the Department's central file, part of RG 59: General Records of the Department of State. The records consist of communications back and forth between the Department and American diplomatic and consular posts, internal Departmental documentation, communications with other government agencies and private organizations and the public, communications with diplomatic and consular officials from other countries in the United States, and related materials.

The central files described below have been declassified and, with the exception of those few documents requiring continued protection or as otherwise explained, are open and available for public use.

From 1963 to 1973, the Department's central file is arranged according to a pre-determined subject-numeric filing scheme. The files are divided into the following time blocks: February – December 1963, 1964-1966, 1967-1969, and 1970-1973. The records are arranged in seven broad subject classes: (1) Administration; (2) Consular; (3) Culture & Information; (4) Economic; (5) Political & Defense; (6) Science; and (7) Social. Each of the subject classes is further divided into primary subjects, which are further broken down by country, region, or organization. For example, the Political & Defense subject is divided into Communism (CSM), Defense (DEF), Intelligence (INT), and Political Affairs & Relations (POL). There are about 55 different primary subjects. Subjects are further broken down by numerical designations. For example POL 12 covers "Political parties" and POL 12-3 is for "Meetings & Conferences" of political parties.

Each subject is divided by country, region, or organization. The country designator for Brazil is "BRAZ."

Many of the files relating to defense affairs ("DEF") and political affairs ("POL") have the potential to include documentation of interest. The following primary subjects within those and other subject classes are specific files categories especially likely to include documentation of interest:

On July 1, 1973, the Department began phasing in a new filing system. In the new system, records were no longer arranged by subject. Documents were indexed using an automated tool with most telegrams being stored electronically, and hard-copy documents (beginning January 1, 1974) being stored on microfilm. Researchers may gain access to the declassified electronic telegrams, index information about the microfilmed documents, and limited information about still-restricted telegrams and index information in the Access to Archival Databases (AAD) on the NARA website at http://aad.archives.gov/aad/. The National Archives has accessioned all of these records through 1976. The FAQs about the records includes more information about the organization and use of the records. The National Archives has accessioned the 1977 electronic telegrams but technical and archival processing of those records is not complete. Until those records are made available on AAD, the Department of State can respond to requests for those records.

The National Archives has accessioned the hard-copy elements of the central file for the period 1977 through 1979, but has not accessioned the electronic finding aids necessary to use those

records. Until the electronic finding aids are accessioned and technical and archival processing completed, the Department of State must provide the citation information needed to locate documents among the hard-copy files.

Central file records dated 1980 and later remain in the custody of the Department of State.

B. Decentralized Files

Also part of RG 59 are decentralized records of various high level, geographic, and functional offices of the Department. Those files can be a valuable supplement to the documentation found in the central files. While pertinent documentation might be scattered among the files of other offices, files from the Bureau of Inter-American Affairs, the Bureau of Human Rights and Humanitarian Affairs, and the Office of the Legal Adviser will be of most interest:

II. Records of Foreign Service Posts of the Department of State (Record Group 84)

Records of Foreign Service Posts of the Department of State includes the files of the U.S. embassy and consulates in Brazil. To a large extent, those records duplicate the materials found in the central files, although there may be some documentation of a local nature not found among the headquarters records. The filing and preservation of the records have changed over time and many of the files dating after 1948 have not been preserved. The filing of records at post parallels that of the Department's central file. Many of the files relating to defense affairs ("DEF") and political affairs "POL") have the potential to include documentation of interest. The following primary subjects within those and other subject classes are specific files categories likely to include documentation of interest. Sub-files were not always used by posts:

IV. Records of the Agency for International Development (Record Group 286)

Records relating to U.S. assistance to foreign police forces are found in the files of the Office of Public Safety (OPS), part of the RG 286: Records of the U.S. Agency for International Development. The files include records of predecessor organizations. The program of assistance to foreign police forces began during the Eisenhower Administration as the Overseas Internal Security Program (OISP). During the Kennedy Administration, the program was given new impetus, and OPS was established in the new Agency for International Development. Most offices ceased operation in 1974 and the program officially ended in February 1975. Documentation relating to Brazil is found among the following series:
