TWO SEPARATE EMISSARIES OF NGO DINH CAN, BROTHER NGO DINH DIEM, CONTACTED CONSULATE AFTERNOON NOVEMBER 2/SEEKING OUR POSITION ON POSSIBLE ASYLUM FOR CAN. EMISSARIES STATED CAN WISHED TO KNOW IF CONSULATE WOULD ASSIST HIM HIM IF WORST POSSIBLE CIRCUMSTANCES DEVELOPEX AND CAN BELIEVED HIS LIFE WAS IN EMINENT DANGER. ONE EMISSARY WENT TO CAS, THE OTHER DIRECTLY TO THE CONSUL.

BOTH EMISSARIES WERE INFORMED THAT NO ASSISTANCE COULD BE RENDERED CAN OTHER THAN THAT ALLOWED FOR UNDER TWO FSM 225.2 RELATING RESTRICTIONS ON EXTENDING ASYLUM. QUOTE IKKRO (AS RECD) EMINENT DANGER FROM MOB VIOLENCE UNQTE SECTION SPECIFIED IS SOLE CIRCUMSTANCE UNDER WHICH CONSULATE MIGHT OFFER SOME ASSISTANCE. IT ALSO POINTED OUT THAT CONSULATE PREMISES NOT INVIOABLE, AND THAT SHOULD CAN BE AT CONSULATE AND GVN OFFICIALS REQUESTED HE BE TURNED OVER TO THEM, CONSULATE WOULD HAVE CHOICE BUT TO COMPLY.
