KELLY MANNARINO has not been observed at the cottage during the past couple of months, except for brief, infrequent visits to inspect progress as to construction additions and refinements. The cottage is now completed and is equipped for full-time occupancy, if so desired. It consists of three bedrooms, bath, living room, dining room, kitchen, screened-in patio porch, detached two-car garage, and detached dog pen and kennels. The small lake in front is filled and landscaping has been finished, including natural tree removal, construction of a stone retaining wall, and planting of evergreens and grass A caretaker spends a lot of time, on an apparently irregular basis, feeding the three German Sheperd dogs, mowing the grass, cleaning up debris, and maintaining the house interior. expected that KELLY MANNARINO will soon commence regular residence at the cottage.
