A. AMCORE-2 OBVIOUSLY HAS INFLUENCE ON INBERT.

B. BANKER MOST CONCERNED DURING DAY 25 AUGUST BECAUSE OF UNEXPECTEDLY TOUGH STAND TAKEN BY INBERT AND GNR IN GENERAL WHICH NOW DELAYING SETTLEMENT. THIS CONCERN INCREASED BY RUMORS AND ONE [STATION] REPORT FROM [LMDAM-1] THAT INBERT PLANS TO ANNOUNCE HIS COMPLETE WITHDRAWAL FROM NEGOTIATIONS DURING RALLY ON 29 AUGUST.
