1. **SUBJECT** has been under investigation by this office since March 1946 and it has been reasonably well established that **SUBJECT** was or is connected with a Soviet Espionage Ring operating in **AUGSBURG (M49/Y37)**. Present investigation is aimed at consolidating the results of all previous investigations together with all new information available.

2. SYNOPSIS OF PREVIOUS INVESTIGATION:

b. Following is a consolidation of the information contained in the reports listed in paragraph 2a.

- (1) On 13 March 1945 SUBJECT was arrested by this office in connection with the Bingo Swoop Operation and imprisoned in the AUGSBURG City Jail for interrogation. SUBJECT claimed that his father, a Russian, had taken up residence in RIGA, Latvia, prior to 1914 where he married Natalia, nee DALLS. SUBJECT claimed to have been born in RIGA where he had lived until the occupation of Latvia by Russian troops in 1940. In October 1942 SUBJECT joined the "Latvian Corps" fighting the Germans under the supervision of the Soviet Army. He was sent to OCS in SARAIK near ROSSON and upon completion of the course was appointed first lieutenant in the "Latvian Corps". SUBJECT was appointed commander of the 2nd Infantry Co., 771st Rifle Regt. In November 1943 he was promoted to the rank of captain and made CO of the 1st Rifle Bn., 771st Rifle Regt., at the time deployed at VITBOK. Shortly thereafter SUBJECT was promoted to major and was appointed assistant Regimental Commander in charge of the 3-3 and 3-4 sections. On 20 March 1944 SUBJECT was taken prisoner by German troops in REVAL, Estonia, and, since he had been wounded, he was sent to a PW hospital in DVINCK, Latvia. On 16 July 1944 SUBJECT claimed to have been released from the PW Camp because of the intervention of his mother and his uncle who allegedly was a professor of geology in some Latvian university. SUBJECT then took up residence in his mother's apartment in RIGA. On 24 September 1944 SUBJECT was sent by the Germans to DANIG, arriving there in December 1944. From there he was moved on to ROSSENHAIM near BERLIN (M53/275), where he stayed three (3) weeks in a camp for evacuated persons. In February 1945 he was transferred to a PW camp in SOAR, GDR where he was attached to a labor commando. On 14 April 1945 SUBJECT was transferred to FURSSEN (M48/D25),

Bavaria, where he worked four (4) days until the occupation of this town by American troops. From 18 May 1945 until 18 June 1945 SUBJECT lived in a DP camp in GARMISCH (M48/D58) from where he was transferred to the Hochfeld DP Camp in AUGSBURG. Since he feared repatriation to his native country, SUBJECT found himself a private apartment at Oberlanderstrasse 132 where he allegedly lived until 14 September 1945. Again to escape repatriation SUBJECT moved to another apartment in SPANHART (quarter of AUGSBURG), Elsassenerstrasse 6, where he lived until his arrest by this office in March 1946.

(2) On 16 July 1948 the British Intelligence Division in a letter to Group Headquarters KCCOM reported that reliable sources (unspecified) had informed them that JAKUSHOV had been a captain in the Soviet Navy and that during the war he had worked for the MVD. SUBJECT was also believed to have been a member of "Operation Zeppelin" (AN: SD Intelligence Organization operating in GSR 1944 to 1945 employing predominately Russian agents) as a Soviet agent, and is considered by the RIA as one of their most able counter intelligence agents. (No Eval)

(3) On 15 February 1947 SUBJECT was interrogated at the 7767 MIS Center and stated as follows:

20 Jul 14* Born on an estate near Ryazan (southeast of Moscow) as illegitimate son of Foreman on the estate. * (According to the old Russian calendar; the modern date would be 2 August 1914)

1917 Moved with his mother to her home village in district of Inzar (Mordeyevsk Autonomous SSR). His father left for Moscow and has not been heard of since then. Lived on farm of grandfather and went to village school.

1929-1932 Went to Inzar secondary school.

1932 Went to Murmansk where he had friends, but his drunken disorderliness compelled him to return home.

Nov32-Jan35 Entered a trade school for rope weaving, but as he did not belong to the Communist Party he was unable to continue there.

Feb 33 Married Anna Katsapova

Sep 33 Accepted teaching position at primary school in village of Kolesasov.

1935 Separated from his first wife; married Marie Baranova.

Feb 36 Lost his job because of drunkenness and remained out of work for rest of year.

- Jan 37 Went to Kuznetsk and there became principal of Public School No. 14. At the end of session, went to Severnoprutsk as chief of local educational committee.
- Jan 40 Dismissed from his job, ostensibly for drunkenness, or possibly for not being a member of the Communist Party. At this time, he divorced his second wife.
- Oct 40 Obtained job in "Kuznetsk" trust; denounced his boss for embezzling funds.
- Aug 41 Transferred to outskirts of Kuznetsk.
- 28 Sep 41 Arrested by NKVD, accused of embezzling 2,000 rubles, and of shirking military service; Jakuschow claims that this was result of his altercation with former boss. Received ten years of hard labor and was sent to labor camp.
- 6 Oct 42 Freed upon request to go to the front and joined 37th Rifle Regt.
- Nov 42 Sent to Voronezh. ~~CONFIDENTIAL~~
- Mar 43 Wounded in hand and admitted to hospital in Saransk, where he was, in spite of his protests (?), accidentally registered as first lieutenant.
- 5 Jul-
20 Sep 43 Assigned to 178th Reserve Regt. in Kurak. For not preventing a brawl between other officers, he was demoted to private and given three months in a penal battalion.
- Mar 44 Sent to front, made platoon leader and ordered to take a certain height. Wounded and captured by the Germans, he was taken to various hospitals, first to Orsha and then to Borisov, where the ROA was recruiting men for its ranks.
- 20 May 44 "Almost entirely without his consent" Jakushev and three of his fellow captives were transferred to an ROA unit. They were given German uniforms, but with different shoulder patches.
- Jun 44 After first having been taken to Minsk, he was assigned to work in Riga. Did clerical work in an intelligence unit in connection with documents, under a man called (fau) Delle, probably providing German agents sent behind the Russian lines with the necessary documents.

- 24 Sep 44 Sent to Litan.
- 9 Oct 44 Evacuated to Masel where transport was bombed, and Jakushov was wounded in leg and head. Admitted to hospital in Koenigsberg.
- Nov 44 Sent to Kolberg to join his unit and spent some time at the hospital in Glibing where he had an operation performed. He did not work himself and confined himself to watching a colleague called Smirnov work on documents.
- 30 Jan 45 Went to Berlin with family of Delle and refused to do any work in spite of threats by the Germans.
- 13 Feb 45 Went to Marienbad (Czechoslovakia). Was supposed to register at a camp in Topla (near Marienbad), but managed to have himself discharged. Ordered to wear insignia of a major in the Wehrmacht, which he did for a few days.
- 14 Apr 45 Hitchhiked south to Pussen, and remained hidden in the mountains while in vain attempting to establish contact with advancing US forces.
- 12 May 45 Went into Oberammergau and got in touch with US authorities, who sent him to a DP camp in Garmisch.

(4) At the time of Sweep Operation BINGO one Eduard REICHARDT, SUBJECT's former landlord, residing at 162 Oberlanderstrasse, AMMERGAU, was interrogated and stated that while JAKUSHOV, lived in his house he (SUBJECT) had told him that he was to be entrusted with an important mission from MOGON in connection with Communist activities in Germany. REICHARDT, who was a local Communist functionary, further stated that at that time he had frequently seen SUBJECT in Russian Army uniform with the rank insignia and that JAKUSHOV on one occasion had shown him credentials identifying SUBJECT as major in the Red Army. The report further mentioned that JAKUSHOV is said to have had a large radio set in his room at 162 Oberlanderstrasse to which he listened regularly every night, and a mechanic who was once called in to repair it had stated that it contained an illegal type of meter

(5) During the same interrogation SUBJECT admitted having had in his possession NKVD credentials which however he claimed were forged. A list, compiled in MARIENBAD, GDR on 23 March 1945 and containing the names of members of the Wehrmacht working for the Hauptamt fuer Propaganda, i.e. the intelligence agency of the Vlassov Army, has been found and SUBJECT figures on this list under number 51 as major of the SD. His own explanation, when faced with this evidence, that in the turmoil at the time he did not know on what list his name

had been entered, is highly unconvincing. The following identity documents were found on SUBJECT's person at this time. A certificate made by German authorities in ALEING dated 19 January 1945 stating that all his personal papers were lost in an air raid; an AEG registration certificate dated AUGSBURG 23 July 1945; an identity card from an AUGSBURG DP Camp dated 19 November 1945; a certificate of registration with the AUGSBURG labor office dated 5 January 1946. (C-3)

(6) On 17 May 1946 S/A Ludwig OPPENHEIM of this office questioned Frau REICHARDT at her home 162 Oberlaenderstrasse. Frau REICHARDT stated that SUBJECT frequently wore a Russian uniform while residing at that address and had shown her his decorations and Major's rank insignia. The same report also mentions that SUBJECT's wife Anna had served as interpreter for the Soviet Repatriation Mission (AN: Location unspecified). One Shura SCHLIFORSTOVA, mistress of JAKUSHEV's closest associate, Nikolai MAYLOR, stated to source "A-29" (AN: unidentifiable at this time) that JAKUSHEV told her that he had worked for three (3) years in the "Counter Espionage Service." (No Eval)

(7) In May 1946 SUBJECT told "A-29", who posed as a co-prisoner, that he would pretend to be anti-Communist during interrogation. SUBJECT further admitted that he was in contact with several "supreme leaders of the undercover organization" (AN: unspecified), and that SUBJECT was well informed as to the constitution and manner of work of the CIC as he had been engaged in the same work for the Soviet Union. (No Eval)

(8) On 21 May 1946 an unnamed Russian major appeared at the AUGSBURG Public Safety Office requesting SUBJECT's release from custody for purposes of repatriation. This request was denied by Lt. (Inf) McDONALD, PSC. (A-2) The following day S/A GASTON of this office was handed a letter at the G-2's office 9th Divisional Headquarters, dated 10 May 1946 requesting SUBJECT's release for repatriation to Russia as SUBJECT was being charged with membership in the ROA (Russian Army of Liberation). The letter was signed by a Lt. Col. (Inf) GAVRILOV, Senior Repatriation Officer, of 3rd US Army Headquarters. (A-1)

(9) In August 1946 an unspecified source reports that one of SUBJECT's agents is one Nikolai BELENKO & VINOGRADOV, who during the war allegedly was sent by the RIS to the US Zone of Germany, where he found residence in the OBSRAMMELGARD DP Camp. Further listed as SUBJECT's agents were Boris LEVIN, Vladimir BUDRICO and one (Inf) YAKOVUT. (Source unnamed, F-6)

(10) On 3 January 1948 JAKUSHOV was arrested by the 15th CID Detachment AUGSBURG on a charge of having MFCs in his possession. During interrogation he stated that he was born in RIGA, Latvia 20 July 1914 and was a major in the Russian Army until 1945. (A-1)

(11) A TIB source reported that in August 1947 JAKUSHOV was the leader of a Soviet agent group in AUGSBURG and that one Nikolai WAYLOR was his deputy. Other members of the group were (fnu) YARINSHEV, Grigori POSTYAKIN, Marko ADRIA, (fnu) ZALIYKGO, (fnu) CHUVALEV, Grigori BOKHVA, (fnu) KOVALEV, and (fnu) LEIBA. One (fnu) PRIKASCHIKOV of Hochfeld DP Camp allegedly told source that SUBJECT, in the summer of 1945, appeared at Hochfeld in the uniform of a Russian major, identified himself as a member of the MVD, and demanded billets. PRIKASCHIKOV took SUBJECT to the Buergermeister of HAUBERTZEN, who billeted SUBJECT in a private apartment. SUBJECT then allegedly collected names of DPs until he was arrested by DIC. One (fnu) CHUVALEV told the same source that in February 1948 he was told by a captain of the Soviet Mission in MUNICH that he could regain the good graces of the Soviet Union by contacting JAKUSHOV at Judenbergrasse 18, AUGSBURG, and following his instructions. When CHUVALEV appeared at SUBJECT's house SUBJECT was in jail and SUBJECT's wife Anna referred him to WAYLOR. WAYLOR then gave CHUVALEV the mission of penetrating ex-Col. (fnu) ZEMIANOV's organization which allegedly was working against the Soviet Union in MUNICH. Source (not CHUVALEV) then succeeded in gaining WAYLOR's confidence and in May 1948 WAYLOR gave source a number of definite MEIS (enumerated therein the original report). WAYLOR also told source that SUBJECT would be released from jail on the 27 July 1948 and that on 28 July there would be a meeting at which source would be introduced to JAKUSHOV who would again take over the leadership of the group. WAYLOR in June 1948 sent this source to contact one Pavel CHAUS living at the Comme Kaserne in AUGSBURG to investigate CHAUS' recent inactivity. CHAUS admitted to source that he was working for the SIS under a certain (fnu) VISHNEVSKI, who, at the end of 1947 was sent to Palestine by the SIS. CHAUS had then been ordered to report to JAKUSHOV but when he found that JAKUSHOV had been arrested he (CHAUS) had discontinued further intelligence activities.

(12) On 7 October 1948 SIGCOM Intelligence Division reported that JAKUSHOV received orders from Col. (fnu) BORASCHNIKOV, Chief of SEM in ANSBACH (MSO/TOA), and that WAYLOR acted as courier between BORASCHNIKOV and SUBJECT. An unnamed source was also reportedly introduced to one Vasili PHILLIPWITZ through SUBJECT's agency. PHILLIPWITZ also is attached to the Soviet Repatriation Mission in ANSBACH and allegedly gave source a set of MEIS. (No Eval given, source unidentifiable. This report, however, probably originated from TIB).

(13) The TIB source reported that SUBJECT is in close contact with the SEM in ANSBACH, which entrusted him, JAKUSHOV, with the organization and operation of an intelligence net in AUGSBURG. Source claimed to have penetrated this organization April 1948 and on SUBJECT's recommendation applied for intelligence work with the SEM ANSBACH in writing, including an autobiography. Later he noticed that he was being investigated by SUBJECT who accidentally admitted checking into source's file several months later source received a letter telling him to report to ANSBACH where he went on 21 September 1948. Source further reported that PHILLIPWITZ submitted the following MEIS to SUBJECT:

- (a) Reaction of the German population to the currency reform.
- (b) Report on military information such as location of army units, supply dumps, etc.
- (c) Location of airfields, strength, number and type of planes, etc.
- (d) Maps of cities in Schwaben with US installations inked in.
- (e) Reports on political leaders among DPs, etc.

(14) According to this source, SUBJECT's intelligence activity ceased toward the end of 1948. Reportedly SUBJECT's previous large scale black market activity was for the purpose of financing Soviet agents passing through his sector. SUBJECT's reason for his present inactivity is reportedly due to the fact that SUBJECT expects arrest in the near future and wants to be prepared in case of raids. He allegedly appointed Iva KOLOS as his successor. (E-3) Named as belonging to JAKUSHEV net at the time are:

(15) On 11 March 1949 unnamed source was informed by a stranger sent by Col. BORACHNIKOV that the following ANSBACH agents would remain in AGCSBURG after dissolution of the ANSBACH Mission: Ilya JAKUSHEV, Peter YELANSKI, and (fau) NIELSKI, et al. (Source TIB F-6)

4. On 30 August 1949 SUBJECT was arrested by agents of this office on the grounds that he had willfully and knowingly falsified documents and had willfully given false information in matters of official concern. This arrest was predicated on the Visa application SUBJECT had submitted. During interrogation of SUBJECT conducted at this office on 30 and 31 August 1949, SUBJECT admitted having been a member of the German Wehrmacht in GDR during the early months of 1945 in the rank of major. Detailed questioning on this point precluded any misunderstanding of SUBJECT's statements in this regard. (A-1) SUBJECT's admission of membership in the Wehrmacht had been confirmed through previous reports and could be substantiated through the testimony of two (2) witnesses (see below) who saw SUBJECT in the uniform of a German major in BERLIN in March and April of 1945. (B-2)

5. Investigation had developed that SUBJECT in his application for DP status filed in May 1949 and in his application for emigration, which he filed in July 1949, had failed to list his Wehrmacht service and had, because of this omission, obtained DP status and eligibility for emigration. On 1 September 1949 SUBJECT was transferred to the custody of HICOG and remained in investigative custody until 3 November 1949. IRO officials, in particular Miss Amy McDERMOTT, Chief of IRO Area 5 Control Center, were informed by this office of SUBJECT's Wehrmacht background and as a result deprived him of his DP status. (A-1) Miss McDERMOTT then questioned SUBJECT at her office and SUBJECT denied to her ever having been a member of the Wehrmacht or to ever have made a statement to that effect. (B-2) SUBJECT at present has been released on bail and is awaiting the completion of trial on charges of document falsification and willful concealment of information of official concern. (A-1)

6. Source "A" reported that at 1730 hours 18 October 1949 Radio RIAS in one of its regular broadcasts beamed at the US Zone of Occupation, announced that one Ilya Dmitrovitch JAKUBOW had been arrested.

by the American capitalist war-mongers and was being kept in custody unjustly for more than two (2) months. (C-2)

7. On 20 September 1949 this agent interrogated one Michael KALUGIN @ Michael COLOMEN, Russian, residing at Lucille Grannstrasse 43, MUNICH. KALUGIN had been a lieutenant colonel and Chief of the Intelligence Section of the ROA stationed in BERLIN and MARIENBAD, GDR in January and March 1945 respectively. KALUGIN stated that he first made SUBJECT's acquaintance in January 1945 when SUBJECT, then a captain in the Wehrmacht, came to him at his BERLIN office and applied for a position with the ROA. JAKUBOW at that time informed KALUGIN that he was a member of the SD (Sicherheitsdienst--Security Service). KALUGIN stated that he disapproved SUBJECT's application because he, KALUGIN, was of the opinion that any member of the SD was undesirable for membership in the ROA. Nevertheless KALUGIN had SUBJECT investigated through informants and other means at his disposal at that time and had determined that SUBJECT had been a captain in the NKVD in MOSCOW/Russia prior to 1941. That in March 1944 SUBJECT was sent by the SIS to Latvia to aid the Partisans in their work behind German lines. In March 1944 SUBJECT was apprehended by the SD in RIGA but was later taken into the SD in connection with Operation Zeppelin (see above) through the agency of one Sturmbannfuhrer (fnu) KRAUS. KALUGIN states that the above statements were told him by JAKUBOW and confirmed by his investigation of SUBJECT.

a. In April 1945 KALUGIN met SUBJECT again in MARIENBAD. At that time the ROA units stationed in MARIENBAD were preparing to retreat toward MUNICH. JAKUBOW, who was by then a major in the SD as indicated by his epaulets and skull insignia on his cap, requested permission from KALUGIN to join KALUGIN's unit in its retreat toward MURNAU (M48/Y50). Shortly before the Americans overtook KALUGIN's unit in the immediate vicinity of MURNAU, SUBJECT showed credentials identifying him as a "Hero of the Soviet Union" to a number of KALUGIN's troops and urged them to desert to Russian units supposedly attached to the American Army (may have been Russian liaison Officer and staff). This was reported to KALUGIN who then summoned SUBJECT, saw the above mentioned credentials which he described as a red cardboard booklet approximately the size of CIG credentials, bearing the seal of the Soviet Union on the outside. Inside it had SUBJECT's picture and a statement to the effect that SUBJECT was a certified "Hero of the Soviet Union." The official stamp of the "Supreme Council of the Soviet Union" was affixed to the document.

b. In view of the uncertainty of the times and the fluidity of the situation, KALUGIN refrained from having SUBJECT shot but forbade him further contact with KALUGIN's unit and dismissed him. The following day KALUGIN and his unit gave themselves up to the Americans and were interned at the SHV Camp at GARMISCH. SUBJECT was also caught by the Americans and interned at the same camp. A few days later KALUGIN escaped from the camp because he feared repatriation; however, through his contacts at the camp, he learned that JAKUBOW had gone to the camp commander, had shown him his credentials, and had demanded to be put in touch with the Red Army and be accorded officer's privileges and recom-

dations in the camp. To a certain extent these demands appeared to have been realized as SUBJECT, according to KALUGIN, appeared to have a position of some consequence in camp, terrorized the camp inmates, and in general gave pro-Soviet speeches urging repatriation. KALUGIN was informed in May 1945 that SUBJECT had reportedly gone to VIENNA to see one Gen'l (fau) GOLNIXOV, who supposedly was a relative of SUBJECT's and in charge of Russian repatriation activities for Germany and Austria. KALUGIN states that he has had no further personal contact with JAKUSHOV. (B-3)

8. On 15 September 1949 a written statement from one Nikolai WEHLUGIN, at present residing in the SCHLAISCHHEIM (M49/Y67) DP Camp near MUNICH, former colonel in the ROA, Chief of Intelligence Service ROA, was obtained. WEHLUGIN stated that in January 1945 SUBJECT came to his office, which at the time was located in BERLIN-DEGENDORF, and applied for intelligence work in the ROA. SUBJECT stated to WEHLUGIN that he at that time was working for Operation Zeppelin, a section of the SD. WEHLUGIN stated that he turned the matter over to Col. KALUGIN for investigation. WEHLUGIN claimed to have received an official report through his intelligence channels in April 1945 with positive evidence to the effect that SUBJECT was an agent of the Russian counter intelligence service. (SECRET) (B-3)

9. On 21 September 1949 this agent interrogated Prof. Wladimir WASSILAKI, Ukrainian, residing AUGSBURG HAUNSTETTEN, Tatenbachstrasse 17. WASSILAKI stated that he first met SUBJECT in MARIENBAD, CBR in March 1945. WASSILAKI, who at that time was in charge of the propaganda section of the ROA, ate at the same officer's mess at which JAKUSHOV would have his meals. Although they never became closely associated, they met almost every day. WASSILAKI stated that SUBJECT wore the uniform of a major in the Wehrmacht and had several German decorations. His cap bore the skull insignia of the SS which, according to WASSILAKI, was worn by all members of the SD in MARIENBAD. A short time later WASSILAKI learned that SUBJECT had been arrested upon orders of Gen'l VLASSOV on suspicion of pro-Soviet espionage, but had been released again through intervention by the Gestapo. (SECRET) (B-3)

10. WASSILAKI then did not see SUBJECT again until he met him on 15 September 1945 in AUGSBURG. According to WASSILAKI SUBJECT expressed surprise and pleasure in seeing him and suggested to WASSILAKI that if he would work with or for SUBJECT he, WASSILAKI, would earn a great deal of money and derive other benefits. In view of the fact that WASSILAKI declined the offer SUBJECT never did specify the nature of this work. WASSILAKI presumed that it entailed pro-Soviet intelligence work in view of SUBJECT's expressed pro-Soviet attitude at that time. A short time thereafter SUBJECT, a close associate, Nikolai MAYLOR, and one Ivan SADOVSKI appeared at WASSILAKI's residence during his absence and threatened his wife with forceful repatriation, telling her that a car of the Soviet Mission would pick her and her family up the following day and transport them to the Russian Zone of Occupation. WASSILAKI then requested protection from the IRO Director at HAUNSTETTEN and got in touch with CIC. SUBJECT then made no attempts at abduction. (B-3)

10. On 13 January 1948 SUBJECT was arrested by the 15th CID Det, for possession of MPCs and stated under interrogation by CID that he had been a major in the Russian Army during the war. At that time CID also came into possession of a set of SUBJECT's credentials No. AK-290 identifying him as a NKVD agent. The credentials were turned over at that time by CID to Headquarters 7970th OIG Group, FRANKFURT (LSI/M67) against receipt. CID files give no further details. (A-1)

11. One Konstantin LIUBINSKI, Russian national, was interrogated by this agent in AUGSBURG 9 September 1949 and stated that SUBJECT had told him personally at the end of 1947 that he, SUBJECT, had worked with the NKVD border guards in MURMANSK, Russia prior to the war and that in 1944 he had been a member of the Abwehr under Gen'l GUDRIAN with the rank of major. (F-6)

12. On 3 September 1949 this agent interrogated one Grigori IZ-CHENKO, Russian national, residing in AUGSBURG, Kiensengerstrasse 9. IZCHENKO stated that he had first met JAKUSHOV in MURMANSK, Russia in 1942, at which time SUBJECT was an official or customs inspector. He did not see SUBJECT again until the fall of 1945 at which time he met him in AUGSBURG and SUBJECT readily admitted to IZCHENKO that he had been with the customs office in MURMANSK at the time of their first meeting. SUBJECT at this time invited IZCHENKO to his quarters repeatedly, mentioning that he, JAKUSHOV, was planning to organize a group here for the purpose of "performing duties for the Soviet Union"; however no mention was ever made of the specific tasks the group would perform or what would be expected of its members. On another occasion SUBJECT told IZCHENKO that he, SUBJECT, had been with the NKVD in the Russian Army in the rank of major; that he was captured by the Germans in 1944 and became a member of the German Army under Gen'l VLASSOV (ROA) until the capitulation. While a member of the German Army SUBJECT claimed to have been responsible for sending German agents into Russia. (F-6)

13. Recurrent through the various accounts of SUBJECT's activity with and for the Germans runs the name of DELLE. Present investigation has disclosed that the man in question is one Pavel or Paul DELLE, allegedly a Latvian who emigrated to the US the end of 1947 and is at present residing at 2991 Denton Street, RIVERSIDE, California. DELLE apparently was a professor of geology at the University of RIGA and in some as yet undetermined manner was connected with the German intelligence service. It appears probable that DELLE acted as SUBJECT's protector and sponsor and was instrumental in obtaining for SUBJECT his position with the OIG. (B-3) A letter from DELLE to SUBJECT dated 6 July 1949 contained among other things the following sentences: "My long silence to you is not due to ever work on my part nor is it that I do not trust you or am afraid of you.....the explanation is much simpler. After my wife has told me everything I find that we no longer have anything more to say to each other. I hope you will have the chance to enjoy life in America. Back in Europe each one of us

has done things which must be forgotten now in order to be able to start a new and free life here in America". (A-1)

14. Source "B" reports that in the summer of 1947 he was witness to a conversation between SUBJECT and one Alfred METZNER. (METZNER had been arrested for war crimes in the Ukraine under suspicion of having been instrumental in the extermination of a great many Jews. While interned at DACHAU (M49/Y76) METZNER succeeded in escaping and has to date not been apprehended). According to the conversation between SUBJECT and METZNER, SUBJECT was involved with METZNER in the killings and each one enjoined the other to silence on this point on the threat of disclosure of mutually incriminating information. On 17 September 1949 this office received an anonymous letter stating that SUBJECT together with a certain METZNER had been active with a German extermination squad. No other details were given. (C-3)

15. On 9 February 1950 this agent interrogated Ludmila PETROV, residing at Reisingerstrasse 23, AUGSBURG, Russian, who stated that she met and befriended METZNER, in the Ukraine in 1942 and 1943 and had come to AUGSBURG with him in March 1945 where she lived with him until the time of his arrest in September 1947. PETROV further stated that METZNER had introduced SUBJECT to her sometime in August 1945 and that since that time she had seen SUBJECT on various occasions about four (4) or five (5) times. PETROV claimed that she had never seen SUBJECT before coming to AUGSBURG, and that METZNER had told her that he met SUBJECT in AUGSBURG shortly after their arrival here. (F-6)

16. On 17 September 1949 this agent interrogated Appolonia and Petro JALANSKI, the latter having been repeatedly reported to this office as a member of the JAKUBSON group. JALANSKI flatly denied any participation in intelligence activity, but stated that as a guest in SUBJECT's home he had been a witness to a quarrel between SUBJECT and his wife. During the height of the quarrel Anne JAKUBSON, SUBJECT's wife, accused SUBJECT of being a Communist, a Soviet sympathizer, and a Soviet agent. This took place sometime in the fall of 1946. At another time SUBJECT allegedly told JALANSKI that he had been a major in the Red Army stationed in MOSCOW and following his capture by the Germans he had attended a German espionage school in RIGA together with DALLE and had become a member of the GIB in RIGA with the rank of major. (F-6)

17. On 11 October 1949 source "B" reported that SUBJECT had told him in 1946 that he was Chief of the Special Section (MVD) of the First Soviet Guard Division while still in Russia with the rank of major and showed him credentials confirming this. (C-3)

18. On 23 September 1949 this agent interrogated Nikolai OSWIAT-INSKI who stated that he had met SUBJECT in May 1946 through one (fnu) CHUVALEV, at present believed to be a member of the French Legion.

Legion. OSMIATINSKI, who was working for an American Intelligence Agency at the time of interrogation, stated that he had succeeded in gaining SUBJECT's confidence and that one day in June 1948 SUBJECT summoned him to his apartment where he introduced him to one Wasili PHILLIPOWITCH, whom SUBJECT later recognized at the Soviet Repatriation Mission at ANSBACH under the name of TROSTNIK. While OSMIATINSKI was at SUBJECT's apartment nothing concerning intelligence work was mentioned. However, when OSMIATINSKI was leaving PHILLIPOWITCH followed him and suggested that OSMIATINSKI work for the Soviet Mission in ANSBACH as an agent and asked him to come to ANSBACH. (P-5)

19. On 6 February 1950 this agent interrogated Favel CHAUS and his wife Hanna, nee BURSHARDT, at present residing at LEIPHEN (L40/X88) DE Camp. CHAUS stated that his knowledge of JAKUBCHOW did not extend beyond vague rumors he had heard concerning SUBJECT's black market activity and that he has personally never met him nor has ever heard of WAYLOR nor VIHNWASKI. CHAUS further denied ever having had any connection with intelligence work in general at the RIS in particular. (E-5)

20. On 6 January 1950 this agent interrogated Eduard REICHARDT at his home AUGSBURG, Oberlenderstrasse 168. Contrary to previous statements REICHARDT had made (see above) REICHARDT denied ever having seen SUBJECT in Russian uniform or knowing anything about SUBJECT other than that JAKUBCHOW lived at his house for a few months in 1945. (E-5)

21. On 9 February 1950 this agent interrogated one Lydia VOITIKIS, nee ABELIS (see paragraph 2b(12), Lydia ABELIS), Latvian, residing at Geoggingerlandstrasse 103, AUGSBURG. VOITIKIS denied having participated in any intelligence activity whatsoever, claiming never to have heard the name of JAKUBCHOW. When shown SUBJECT's picture VOITIKIS stated that she did not recognize him or know him. (P-5)

22. Following is a list of personalities allegedly connected with SUBJECT at one time or another:

a. Lydia ABELIS, AUGSBURG, Geoggingerlandstrasse 103, reportedly worked for the MVD in RIGA, later for the Gestapo. Allegedly member of SUBJECT's net. (Source unkn. E-5)

b. Marko ADRIA, Croatian, whereabouts unknown, reportedly an associate of WAYLOR, active in black market for the purpose of financing RIS activity in AUGSBURG. (Source and eval unkn)

c. Nikolai BALENKO & VINOGRADOV (see paragraph 2b(7)): On 26 January 1950 this agent interrogated one Peter VINOGRADOV, residing Singerstrasse 9, AUGSBURG, Ukrainian who stated that he had never used the alias BALENKO, that he had never been a member of the NKVD or MVD, that he had never been in MOGILEV-on-the-Dnieper, that he had never been in OBERAMMERGAU, and that he did not know SUBJECT, but had merely heard of SUBJECT's black market activities.

28. UNDEVELOPED LEADS AND FUTURE ACTION:

a. Paul DILLB, Latvian, former professor of geology at the University of RICE, present address 8901 Denton Street, RIVERSIDE, California.

29. AGENT'S NOTES:

a. Background Information: A regional file check failed to develop any significant information on the names mentioned in this report other than already noted and/or contained in personality annex in paragraph 28 above.

b. Comments and Opinions:

(1) After a thorough sifting and re-sifting on all available material concerning SUBJECT the following picture of Ilya Dmitrovich JAKUSCHOW emerges in this agent's mind. In the years 1938 to 1944 SUBJECT served as a member of the NKVD (MVD) or another Russian intelligence agency and received a thorough and complete training in espionage and counter intelligence methods. His resistance to interrogation, his methods of creating confusion, and his general attitude during interrogation alone make it appear highly probable that SUBJECT is a graduate of a Russian intelligence school. This is further confirmed by his own statements to WERLUGIN and KALUGIN.

(2) Employed in the intelligence field during the war SUBJECT was captured (or allowed himself to be captured on orders from MOSCOW) by the Germans in 1944 and succeeded in gaining the confidence of the GIC which then used him as an agent. As improbable as it may appear on the surface, this agent believes that SUBJECT actually was in the rank of major in the SD, as research conducted by this agent developed information to the effect that particularly in Operation Zeppelin of the SD, the Germans did make it a practice of hand picking likely Russians from PW enclosures, Ost-Arbeiter camps, etc., for use as agents and that they in some cases were given high army ranks, although the pay scale was considerably less than that of regular German Army officers.

(3) SUBJECT presumably then worked for the SD as a Russian agent with the mission of selecting Russian agent personnel for deployment behind Russian lines. In addition to that this agent believes that SUBJECT was also active in the intelligence section dealing with the falsification of documents and identity papers. At the same

time it appears more than probable that SUBJECT was actually working as a double agent with the mission of penetrating CIS and possibly the ROA.

(4) After the capitulation, SUBJECT appears to have had no trouble in establishing his pro-Allied sympathies to pertinent authorities and for a short time wore the uniform of a Red Army major apparently with proper authorization. Immediately after capitulation SUBJECT also appeared to have rather overt contact with members of Russian missions in this area until suddenly in approximately July 1948 SUBJECT makes every attempt of disassociating himself from official Russian contacts. It appears probable that at this time SUBJECT received his orders from KROKOV to go under cover and establish an espionage net in the AUGSBURG area. This net appears to have been directed from AMSBACH. As primary missions of this net can be considered the gathering of information concerning anti-Soviet DP leaders, American military information and possibly forceful repatriation of Russians wanted by the Soviet Union.

(5) Unevaluated information indicated that towards the end of 1948 SUBJECT was dismissed by his superiors in AMSBACH presumably for lack of activity, indiscretion, drunkenness, and embezzlement of SIS funds. No information has come to light indicating that JAKUSHEV has been engaged in any way in intelligence activity after December 1948. At present his finances appear to be extremely low, which would tend to confirm this supposition.

(6) In this agent's opinion, however, SUBJECT is still an extremely dangerous man and the possibility that he is at present being used as sleeper agent cannot be dismissed. This agent will try to effect a conviction on the charges mentioned above and on that basis will explore all avenues leading to SUBJECT's expulsion from the US Zone of Germany.

c. Recommendations: In view of the fact that Paul DILLE appears to be the only man known to this office who can give an accurate account of JAKUSHEV's activity in 1944 to 1946, this agent recommends that a copy of this report be forwarded to the pertinent FBI office in LOS ANGELES, California for interrogation of DILLE. In view of DILLE's letter to SUBJECT, as quoted above, DILLE can hardly deny having had contact with SUBJECT. It is requested that a report of the FBI interrogation of DILLE be forwarded to this office. It is further recommended that all efforts be made to expel SUBJECT from the US Zone of Germany.
