Dear Mr. President:

Pursuant to your Memorandum of October 22, 2021, "Temporary Certification Regarding Disclosure of Information in Certain Records Related to the Assassination of President John F. Kennedy," I propose that Department of Defense information identified in the enclosed index be considered for continued postponement beyond December 15, 2022. None of DoD's material currently withheld contains any information related to the assassination of President Kennedy. Material proposed for continued postponement includes intelligence sources and methods that are still in use; military defense and foreign relations; elements of active U.S. war plans; and information protected under the Atomic Energy Act of 1954.

The Department will continue to conduct robust reviews of withheld information with the staff of the National Archives and Records Administration and the National Security Council, and coordinate on recommendations for final disposition for your approval according to your direction.
