

During contacts with PSI, endeavor to determine, without revealing the above CIA information, whether he is in contact with any other agency. In this connection, PSI has been connected with MRP which was of operational interest to CIA. It is possible PSI, in his activity for the MRP, was actually doing work for CIA without knowing it since CIA frequently operated in organizations, such as MRP, through cutouts.
