The above letter was in response to Bureau airtel entitled the same dated 3/4/68. There is no indication Houston was in receipt of Bureau letter to Albany dated 8/25/67 captioned the same.

It is noted that this letter only refers to one individual, F. D. KIRKPATRICK followed by the initials "SCLC". There is no indication in any Houston file of any further effort with regard to either KIRKPATRICK or the "SCLC" in general since neither are again mentioned in that file.
