Based on O'Neill receiving 1.0 hrs of pay at the regular rate and 7.0 hrs of premium pay for each evening, Imbordino represented to me that O'Neill was assigned to the midnight shift for the period 7/13 - 8/7/93. Imbordino was unable to discern whether or not O'Neill started his shift at 11:00 P.M. each evening or at 12 Midnight.
