

# How to Order Copies of Passport Applications, 1795–March 31, 1925

The National Archives and Records Administration (NARA) holds applications for United States passports issued between 1795 and March 31, 1925. Applications for passports issued after March 31, 1925, remain with the Department of State. With two exceptions, U.S. citizens were not required to have a passport for travel abroad until 1941. Passports were required for a short time during the Civil War (August 19, 1861–March 17, 1862) and during World War I (May 22, 1918–1921).

### **Written Requests**

If you wish to request a copy of a passport application by mail, send a written request to:

#### What to Include

All requests should include the applicant's full name, passport issuance date, and passport application number, if known. If you do not have the application number and issuance date, please provide the applicant's year of birth, place of residence at the time of application, and approximate year of travel.

# Copies of Passport Applicant Photographs, December 21, 1914–March 31, 1925

The original passport application volumes are at the National Archives at College Park, Maryland. Researchers may obtain copies of the original passport applicant photographs in one of the following ways:

- If conducting on site research, you may request to view the original volume. You may use a camera (no flash permitted) to obtain a copy of the original photograph.
