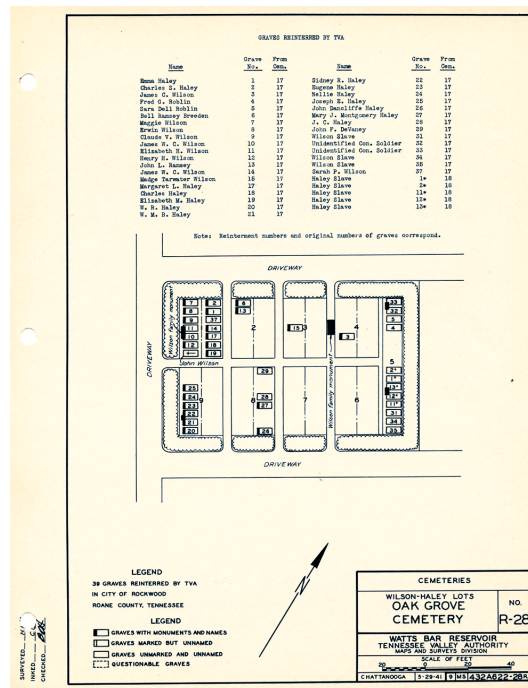

Here are some newly available records in the the Catalog for your research and discovery:

Published Maps, 1947 - 2015, Records of the Central Intelligence Agency, 1894 - 2002

This [series consists of published maps](#) of most countries and world regions. Included are base and briefing base maps; maps depicting terrain, sociological, transportation, political, and economic features; maps depicting administrative, military, and treaty boundaries; maps of urban areas; and maps showing ethnic distributions or narcotics trade routes. Also included are thematic maps, charts, graphs, and organization charts relating to various topics of the Cold War, including the Soviet Union, China, Cuba, and the Vietnam War.

These [records document the Tennessee Valley Authority's massive operation](#) to remove cemeteries from areas flooded for use by electric dams and nuclear power plants.

Crew Lists of Vessels Arriving at Chicago, Illinois, 5/17/1918 - 11/30/1954

This [series consists of crew list forms](#) provided to the Immigration and Naturalization Service by shipmasters whose vessels had last departed from a foreign port, typically a Canadian port.

LIST OR MANIFEST OF ALIENS EMPLOYED ON THE VESSEL AS MEMBERS OF CREW 173

Required under Act of Congress of February 3, 1917, to be delivered to the United States Immigration officer by the representative of any vessel having such aliens on board upon arrival at a port of the United States.

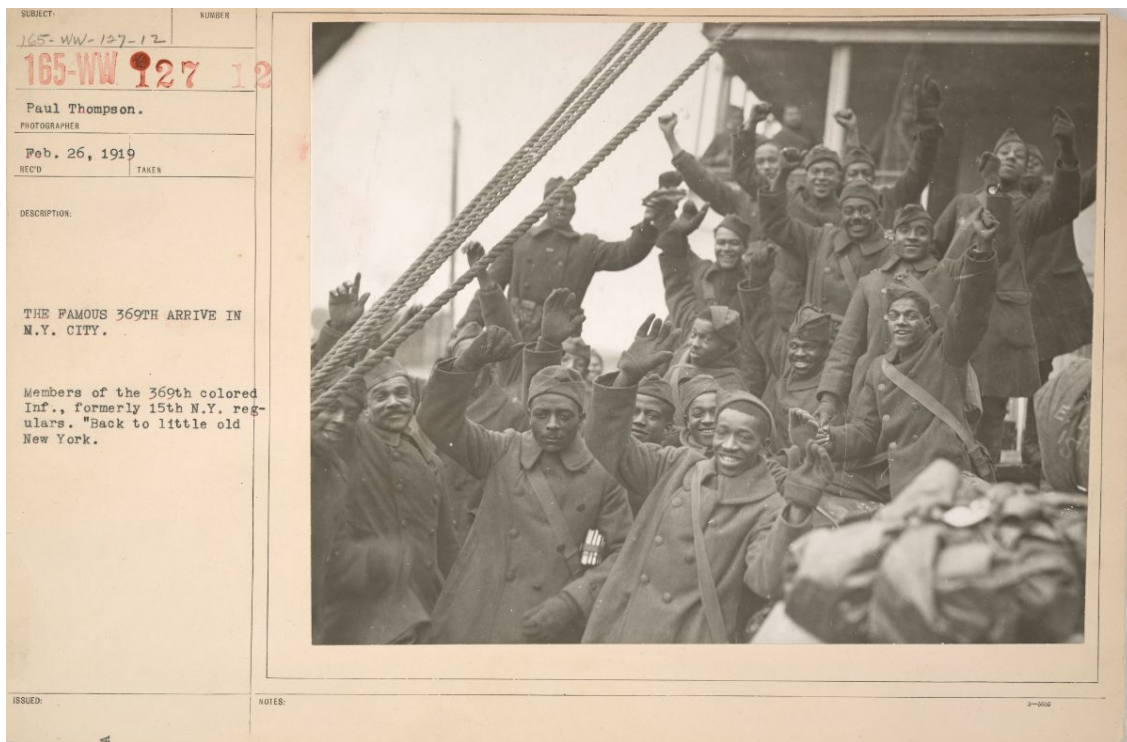

In 1984, to support the growing demand for knowledge of African American history, Dr. Debra Newman Ham, with the help of several other colleagues, took on the responsibility of compiling a guide to black history records at the National Archives. With the publication of *Black History: A Guide to Civilian Records in the National Archives*, the National Archives and Records Administration (NARA) became recognized as one of the primary sources for African American historical documents. To the Honorable the Justices of the Circuit Court of the United States for the first Circuit within and for the District of Massachusetts.

Hetty H. Robinson, of the City, County and State of New York, singlewoman, a citizen of said State and of the United States, brings this her bill of complaint against Thomas Mandell, of New Bedford, in the State of Massachusetts, Merchant, a citizen of said last mentioned State and of the United States, as he is Executor of the last will and testament of Sylvia Ann Howland, late of said New Bedford, singlewoman, deceased, and against Edward O. Mandell, George Howland the younger, Merchants, and William A. Gordon, Physician, all of said New Bedford, citizens of Massachusetts and of the United States, as they are Trustees and residuary legatees under the will of the said Sylvia Ann, and hereupon your oratrix alleges as follows.

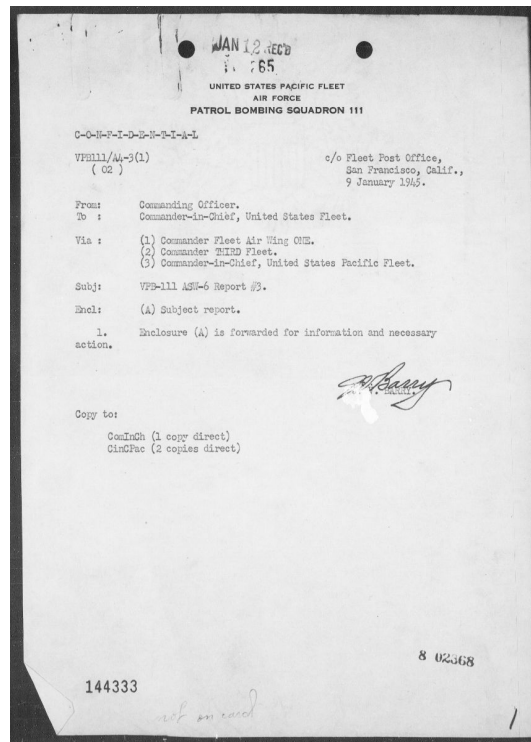
First. That she was the niece and sole heir at law of the said Sylvia Ann, by whom she was educated and brought up, and with whom she lived till within a few years - the said Sylvia Ann taking the place and performing the duties of her sister, the Mother of your oratrix.

Secondly. That in the month of September, A. D. eighteen hundred and sixty, your oratrix was possessed in her own right, of

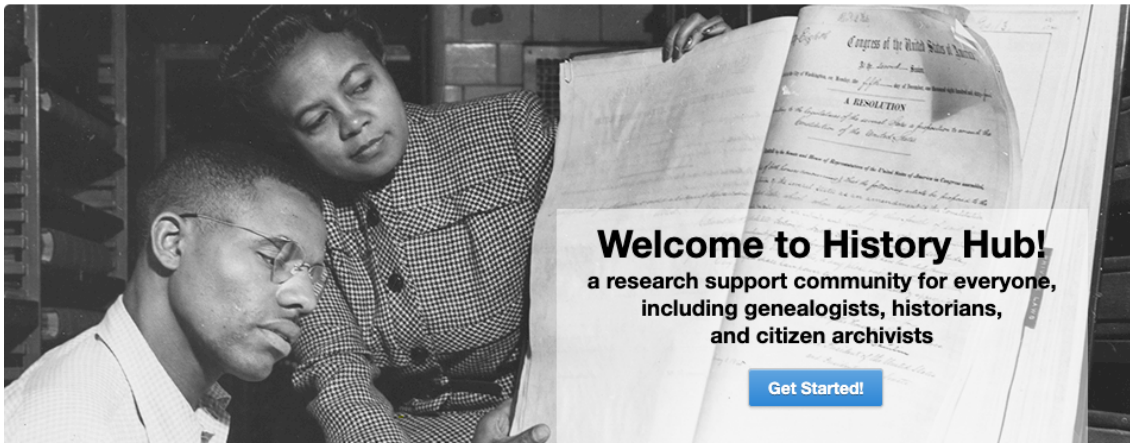
